ECONOMIC BACKGROUND

In 2022, the International Monetary Fund Organization expects that the global economic growth will slow down significantly. The instability of the international situation and the recurrence of the new epidemic will have extensive economic impacts through the commodity market, supply chain and capital side. The shock will lead to a sharp decline in trade. Trade in services continued to be sluggish, but trade in goods rebounded very quickly. Certain factors, such as the pandemic, have played a key role in driving the shift from demand for services to demand for goods. Although the epidemic prevention measures have produced a certain spillover effect on both buyers and suppliers, the impact is relatively small. The trade and industrial chain have shown strong resilience under the current pressure, and opportunities and challenges will coexist in the future.
